

**DEPARTMENT OF HEALTH RESEARCH
NEW DELHI**

A call for proposals was advertised through National newspapers and DHR website under Grant-In-Aid scheme of DHR between July 1, 2019 to August 14, 2019 inviting full length proposals in following 11 areas:

1. Innovation in health technologies
2. Health Technology
3. GIS based disease mapping/surveillance
4. Health Informatics
5. Biomedical imaging and processing
6. Clinical trials for newer drugs/ vaccines/ devices/ kits and tools
7. Disease modeling
8. Health System Research
9. Health Economics
10. Health Policy
11. Environmental Health

In response to the call, 1055 full proposals were received. After screening of the proposals by a Screening Committee; 158 proposals were found suitable under the above mentioned 11 areas. The final decision for funding after Technical Review for these 158 proposals will be communicated to respective PIs in next 6-8 weeks.

Further, it has been decided by the Competent Authority that the remaining 897 proposals will be considered by ICMR under Extramural Adhoc Scheme which will open from 10th December, 2019 to 10th January, 2020. However, the PIs need not to re-submit the same proposal again in ICMR portal (NO NEED TO RESUBMIT).
