1. Research Associates (Two)

Qualification : M.D. / Ph.D. in Pharmacology; Ph.D. in Chemistry / Botany / Pharmaceutical Sciences from a recognized university

Desirable : (i) 2 years experience in handling work relating to natural products / medicinal plants; (ii) Experience in literature search by digital and traditional sources in the field of medicinal plants; (iii) Flair for scientific writing, preparation of reviews, reports, monographs; (iv) Working knowledge in computers

Job Requirement

Literature search relating to medicinal plants/products, compilation of information, preparation/scrutiny of review/monographs etc. and other related work. Preparation of indices and appendices of the monographs.
