Terms and Conditions:

1. Interested and eligible candidates can appear for walk-in- written test and / or personal discussion on the dates mentioned against each post alongwith the duly filled in the prescribed application form (attached).
2. It may be mentioned here that incomplete applications, application not submitted in prescribed format and application without supportive documents asked for shall be summarily rejected.
3. Qualification and experience should be in relevant discipline/field and from a reputed institution / organization recognized by relevant authority.
4. Experience shall count from the date of completion of minimum educational qualification.
5. Submission of incorrect or false information during the process of walk-in- written test and / or personal discussion shall disqualify the candidature at any stage.
6. The Director reserves the right to increase / decrease the number of vacancies as per requirement.
7. Candidate should write the **Name of Project on the top of the application**. Candidates applying for more than one post should apply **SEPARATELY** for each post.
8. No benefit of provident fund, Leave Travel Concession, Medical Claim etc. will be considered, since the posts are purely temporary basis.
9. Age relaxation against post earmarked for reserved candidates will be considered as per Govt. of India Norms. As per GoI rules no relaxation against Unreserved (UR) vacancies will be considered.
10. Age limit and experience will be considered as on the date of walk-in- written test and / or personal discussion.
11. No TA/DA will be paid for attending the walk-in- written test and / or personal discussion.
